**Regarding the approval of The Annual Report of the Board of Directors
for the financial year ended at 31 December 2025**

1. General aspects/competence

As per the provisions of art. 65 of the Law no. 24/2017, republished on August 10, 2021, regarding financial instruments issuers and capital market operations ("Law no. 24/2017"), the companies admitted for trading on a regulated market are obliged to make available to the public, within 4 months since the end of the financial year, the Annual Financial Report, comprising the Audited Annual Financial Statements, together with the Annual Report of the Board of Directors, the declaration of the responsible persons and the financial audit report.

The Annual Financial Report will include all the information necessary for the complete and fair presentation of each element presented in Annex no. 15 to Regulation no. 5/2018 on Issuers of Financial Instruments and Market Operations, with subsequent amendments, issued by the Financial Supervisory Authority ("ASF Regulation no. 5/2018").

2. Presentation

Taking into account S.N. Nuclearelectrica S.A. ("SNN")'s status as a listed company on Bucharest Stock Exchange, SNN prepared the annual report for the financial year 2025, in compliance with the provisions of art. 65 of the Law no. 24/2017 and of Annex no. 15 to the ASF Regulation no. 5/2018.

As per Annex no. 15 to ASF Regulation no. 5/2018, the content of the annual report must include information regarding: the analysis of the company's activity, the tangible assets of the company, the market of the securities issued by the commercial entity, the management of the commercial entity, the financial and accounting statements as well as information regarding its subsidiaries and the company as a whole, if the company has subsidiaries.

In compliance with the regulations of the capital market regarding the annual report, as well as the requirements of the related legislation (Law no. 31/1990, OUG no. 109/2011, OMFP no. 2844/2016), SNN issued The Annual Report of the Board of Directors for the financial year 2025 in compliance with the minimum requirements provided in Annex no. 15 to ASF Regulation no. 5/2018, but not limited to, adding other information of interest for the shareholders, investors and interested parties regarding SNN's activity for the financial year 2025, both at the individual level as well as at the group's level (presenting
