

Public Notice of Tendering Procedure for Construction

1. Subject Matter of the Invitation to Tender

- Invitation No. : E25-S154-000
- Construction Title : Construction of General Building (Package B) for Cernavoda NPP Unit1 Refurbishment Project in Romania
- Budget Amount : EUR 48,360,645(excluding Value Added Tax)
- Construction Period : the effective date of the contract ~ March 2. 2028
- Construction Scope : specified in the Specification, separately attached

2. Tendering Type

- International Open Tendering Procedure - Two stage of tender evaluation procedure

3. Qualification requirements for participation

The qualification for participation in tendering is limited to the following:

- Compliance with Romanian Public Procurement law(Law No.98/2016, Law No.99/2016)
- Compliance with SNN Requirement(Refer to Article 16 of ITT Chapter V. Evaluation Criteria)
- Possession of CNCAN NMC-08(Construction Quality)
 - ※ In case of the tenderers who do not possess NMC-08 certificate: Tenderers shall submit Attachment H(Section 2) at the time of tender submission, and be subject to exclusion based on the results of SNN's audit, which will be conducted upon completion of the price tender evaluation.
- Joint ventures are limited to a maximum of six companies
 - ※ In the case of joint suppliers, ALL suppliers must acquire the required Qualification.

4. Security Deposit for Tendering

- Security Deposit for tendering (5% of tender price) may be replaced with a written promise ensuring that the tenderer will pay the amount equivalent to the security deposit for tendering and tenderer(s) shall submit the written promise using the form provided in ITT Attachment A of Chapter I, upon submission of the tender.

- Security deposit for tendering shall be reverted to KHNP in the following events, and so, in such event, the tenderer shall pay KHNP, in cash, the amount equivalent to the security deposit for tendering immediately upon KHNP's request:
 - The tenderer withdraws the tender before its expiration of validity.
 - The tenderer refuses to enter into the contract after being awarded the contract or fails to submit the security deposit of the contract within designated period without just reason.

○ **Opening of Tender**

- Tender Opening Place is same as Tender Receiving Place.
- The Opening date will be notified later only to the tenderer(s) those who qualified for Construction Performance Capability Evaluation.

6. Decision on the Preferred Tenderer and Awarding of the Contract

In this competitive tendering, the tender shall be deemed valid when there are two (2) or more qualified tenderers, KHNP will select the tenderer who obtains the highest score as the preferred tenderer, combining the Construction Performance Capability Evaluation Score from the first-stage tender and the Price Evaluation Score from the second-stage tender. Only the tenderers who have scored 30 points or more in the first-stage are eligible to participate in the second-stage tendering.

Once the preferred tenderer is determined, KHNP will negotiate the contract conditions and other matters, and upon completion of the negotiation, the successful tenderer will be decided through SNN's approval. However, if the preferred tenderer fails to be awarded the contract, KHNP may designate the next highest-scoring tenderer as the preferred tenderer, without any liabilities to the initial preferred tenderer.

7. Nullification of Tender
